



## **IPR AWARENESS PROGRAM**

QCFI believes that as a developing nation, industry and entrepreneurs should be encouraged to foster a culture of developing intellectual creativity in various industrial and commercial activities in India and abroad, and accordingly, the need to be conscious of rights and obligations governing intellectual creations of the human mind. It is thus important to trace valid and subsisting IP rights in India and abroad and serious thoughts in developing the much needed IP awareness for mapping state of art patent technologies and/ or various forms of jurisdiction specific IP coverage including its various forms and legal scope. Organizations should put serious thoughts in importance of trademark in relation to various products and services offered, patent/ copyright mapping, patent reviews or audits to appreciate scope of developments so as to enable generating skill and expertise for patenting in India and abroad.



## What is Intellectual Property Right (IPR) and its importance

Intellectual Property is basically a legal proprietary right given in recognition of any intellectual creative effort including artistic, literary, technical or scientific creation. Intellectual property right vests upon the creator/ inventor of such intellectual creation/invention to exclude third parties from practicing his or her said intellectual creation/invention without his or her consent for a specified period. Basically, the intellectual property right confers an exclusive right to the right holder or his/ her legal assignee to fully utilize his/ her creation by way of possible commercial exploitation for a given period of time.

In this competitive age, markets are supposed to be driven by intellectual creative efforts of the human mind and thus intellectual property right is bound to play a vital role to protect original creative/inventive efforts and to stop counterfeiting of intellectual property right covered product and processes which would in turn ensure recovery of R & D and other associated costs and adequate profit generation for continued investment for future R & D.

# The intellectual property right can be sought for a variety of intellectual efforts including

#### **PATENTS**

Technical advancements in various fields of technology can be covered for legal exclusivity subjects to meeting of criteria for patentability under the Patents Law.

#### **INDUSTRIAL DESIGNS**

It relates to the intellectual creative efforts on designing of product outlooks and provides legal exclusivity under the Designs Law.

#### **TRADEMARKS**

Marks which identify the source of various goods and services and is covered under the Trademark Law.

## **GEOGRAPHICAL INDICATIONS**

Mark/Identities which qualify a product of particular geographical origin with special attributes/charact eristics and are covered under the Geographical Indications.

#### COPYRIGHTS

Works covering artwork, literary work including original computer software and cinematographic films and sound recordings are considered intellectual creations and covered by the Copyrights Act.
