QCFI HQ has decided and advised chapters to charge Rs.5000/- per case study including GST. However considering the financial crisis due to COVID 19, our chapter has decided to charge Rs.2000/- plus GST per case study irrespective of Quality and allied concepts with a maximum number of five persons.
