This year, convention will be held virtually due to Covid-19 pandemic situation, and so all the case studies will be invited as soft copies. Case studies need to be submitted in word format along with needed figures and pictures or in PPT format with enough description of each case study as per the practice. Any of the submitted copies should be in soft form only and not exceeding 25 MB. The case studies will be evaluated by Panel of Judges in soft form as per the time line scheduled in the brochure. Results will also be declared virtually.

OBJECTIVES:

The main objectives of convention are:

- To learn and understand practical aspects of Quality Concepts.
- To enhance the creativity of participants through Poem, Poster, Slogan and Essay competitions.
- To provide "Recognition" and "Encouragement" to members of Quality Concept Teams.
- Adjudge the best teams from different sectors as per QCFI norms for nomination to national convention at Coimbatore.

RECOGNITION:

- All the teams will be given certificates, based on evaluation.
- Poem, Poster, Slogan & Essay competition winners will get certificates.
- The above certificates will be directly sent to the particular organization through e:mail.

PROGRAM SCHEDULE:

- From 1st to 25th September'2020 : Receiving soft copy of case studies, Poem, Poster, Slogan & Essays.
- Sending of unique registration number to the organizations as a receipt : 26th September'2020
- From 20th to 30th September'2020 : Evaluation of case studies by panel of Judges.
- 31st September'2020 : Announcement of Results through email.
- 1st to 5th October'2020 : Sending virtual certificates on email.

A) Case Study Presentations & Other Entries:

- Language will be Hindi or English
- The case studies, Poem, Poster, Slogan & Essays have to send our Chapter email address “**qcfigwaliorchapter@gmail.com**” writing the subject line as **GCCQC-2020 Competition**.
- For case studies it will be considered that 60% and above will be ‘Gold’, 50% to 59% ‘Silver’ & below 50% as ‘Bronze’ Awards.
- ‘Gold’ & ‘Silver’ categories are eligible to attend NCQC-2020.
- If any participant want to attend the competitions of Poem, Poster, Slogan & Essay, he/she can send maximum one entry for each competition. If any participant of other than registered case study presentation in GCCQC-2020, they have to do the registration as per the details given at payment details.
- All the above entries will be in line with the convention theme “**Developing ‘Self Reliant India’ through Quality Concepts**”.
- They essays should not more than 400 words.
- The Poem, Slogan & Essay can be in word or in neatly hand written format.
- The Poster should be drawn on drawing sheet and scanned.
- The Participant name, Organization name, Team Name etc.details should be clearly mentioned on one side of each entry for Poem, Poster, Slogan & Essay competitions.
