QCFI will conduct the much-awaited Jury Development Programme starting from January 15th, 2020. The objective is to develop Juries for internal assessment and guidance in the unit, act as jury in the upcoming CCQC/NCQC/ICQCC.

JURY Development will cover the following areas

A. About different Quality Concepts: Kaizen, QC, LQC, LSC, QIT, 6 Sigma, 3Ms, TPM, LM, SMED, Poka Yoke, QFD +++, 5S

B. Problem Solving Techniques: Types of criteria for selection of project, problem-solving techniques (BS, FD, PDCA, Activity Chart, Priority/Ranking method)

C. Problem Solving Tools: Basic seven tools, New Seven Tools

D. Problem Solving steps- 12 step method, integration of steps in DMAIC method, 7QC story, etc.

E. Evaluation of the Case study

F. Evaluation of case study presentation

G. Art of asking the Question and reaction of the Judges.

This program will be free for one nominated executive for every 18 Paid delegates from the member, organizations participated in NCQC-2020.

For other interested executives from QCFI Member Organizations, our charges will be Rs 10,000/- + GST.

Evaluation:

1. Task will be given after each lecture session with maximum marks of that task.

2. 10 case studies to be sent to them for Pre-evaluation after training them.

3. Evaluation of case study presentation- 10 Virtual case study presentations to be sent to them after the training session.

4. 5 Questions to be mentioned against each case study sent to them as mentioned in point 3. We will evaluate the quality of Questions being asked after a presentation by the respective jury.

Online JURY Development Program Procedure:

JURY Development Registered participants are requested to login and view the course modules online once you receive the login details.

Login credentials will be mailed to all the registered participants with a user guide. JURY Development will have 20 modules. Each module may be from 1 hr to 2 hrs duration followed by Questions. Module 2 will be opened only when the participant completes Module 1 and also the Homework or Activity associated with it, similarly, each module can be accessed once the previous module and its homework or activity are completed. Complete Jury Development Modules should be completed within 90 days period from the start of your program.

Once logged in to the system, the Dashboard section displays all your courses and their corresponding status – Completed, In-Progress, Assigned. You can log in any time and check the module's content and its status.

JURY Development Course will appear on your dashboard (Start Course) to complete. Clicking on the course tab will open the list of modules. Simply click on them to open them and begin the course.

This online QCFI learning center is designed to help you leverage our digital solutions and support by providing just-in-time training 24/7. This system supports Chrome, IE9+, iOS, and Android. This means that you can access courses in a variety of ways at any time using a computer, laptop, tablet, or smartphone.
