Essay Competition

Topic: Covid '19

- 1 Essay should not exceed 400 words. It should be eligibly handwritten in A4 size white paper, leaving margin of 2 cm on all four sides. They can be either in English or Hindi or Bengali only Quality Circle Member who are participating in the Convention event are eligible. Prizes will be awarded to winners in each category.
- 2 In these three cases, entry should have the name of the Participant and QC Team which he . she represent, alongwith the organization name & category.
- 3 There is no Entry Fee for all the above competitions. For Poster, Slogan and Essay Competitions, the last date for submission is during registration we will receive the same.

Poster & Slogan Competition

Topic: Quality / Productivity / 5-S/Safety

The Poster and Slogan should be sent in soft copy. They can be prepared in English or Hindi. Posters and Slogans are restricted to One Person in each category. Only Quality Circle Members who are participating in the convention events are eligible. Prizes will be awarded to winners in each category as per entry numbers.

IMPORTANT INFORMATION

1. Case Study presentation slot allotment will be declared before the date of convention after full and final payment.
2. It is a must for each QC team to submit the QC meeting register book to the authorized person at the Registration Counter at the time of registration, The same may be collected back from the Registration Counter after the Closing Ceremony. No need to carry them to NCQC '21.
3. Filled up Registration Form including Contact No. & Email address, may kindly be sent within 15th September 2021. At the same time soft copy will be sent to us.
4. The official language is either English or Hindi. Presenters presenting in any other languages should arrange their own translator. You may please use English for better communication.
5. No need of hard copy of the case studies. Please send us the soft copy for pre-evaluation.

GUIDELINES FOR CCQC-2021 (Extract from HQ)

National Convention on Quality Concepts (NCQC'21) will be held in the month of December 2021 for which dates and mode of conduct of NCQC'21 will be decided by end of June 2021 based on the status of Covid '19 at that time.

In pandemic situation, Special Board of Directors meeting was held on 1st June'20. Considering that chapters may not be able to organize CCQC-2020 as had been doing in past, board has then taken the decision to organize the CCQC-2020 in new Normal way and had finalized the criteria for CCQC-2020.

Now seeing the present situation, the board in BOD meeting-155 has taken a decision that CCQC-2021 will be organized in the way we were doing before CCQC-2020. Each chapter can organize in their way based on their COVID,19 situation observing all protocols. Chapters may do it physically / virtually or combination of both. Accordingly, fees will be decided by them.

Case study Evaluation:

1. For Quality Circles- Pre-evaluation +Register +Case study presentation
2. For other allied concepts- Pre evaluation + case study presentation.

Other competitions:

Other competitions are optional e.g. Knowledge Test, Model presentation, Karakuri Kaizen, Home kaizen, Individual kaizen through model and chart, Skit Competition, Slogan, poem, poster, Cartoons etc.

Chapters are requested to send the selected entries and results of the competitions as mentioned in "Other Competitions" (except the results of Knowledge Test) to QCFL HQ for consideration of selection in NCQC-2021.
