Guidelines for Case Study Presentations / Competitions

- Only QCFI Institutional members are eligible to nominate Quality Circle, TPM circle, 5-S, WCM Circle, Kaizen, Six sigma, Poka Yoke, SMED, & Lean QC teams for case study presentations.
- Send your case study in ppt mode with description/ story in WE share or Google drive & send link. Language should be Hindi or English
- Judges will evaluate presentations and their decision will be final and binding. Case study & presentation evaluation criterion are as per HO guidelines. (Refer evaluation Criterion). Winning & Participation certificates will be sent thru email.
- Awards will be given to teams based on evaluation along with e-certificate and trophies will be sent by post. Gold (60% & above), Silver (Above 50 & below 60 %) & Bronze award (below 50%).
- No Knowledge test or Quiz will be conducted. No kit bag will be given to participants.
- For other competitions send your Posters (A-3), Poems (Max 8 lines) and Essay (Max. 25 lines) neatly written or typed on A-4 size paper on the theme mentioned on First page, along with the case studies. E-certificate will be sent to winners in pdf.

OPTIONS-

Option-1 In case instead of making live case study presentation, you want to upload the recorded presentation, you can do so and send us the link through we share or google drive or You tube. Judges will evaluate and have the questions ready. We will allot time of 5 minutes for each team for answering questions by the judges. Only 2 questions will be asked and the teams have to answer within the stipulated time of 5 minutes.

- Option-2 In case you want to be evaluated your team at your location, we can arrange 2 judges. You must have more than 5 participating teams and travel, lodging and boarding cost to be borne by your organisation. In addition, we will provide one day free programme on any of the Quality concept. We will also have discussion on scope of 5-S Implementation.
- Optiion-3 You can do live presentation by travelling at Udaipur. It will be arranged in hotel. It will be spread over many days. Slot and time will be informed. Trophy will be given at a particular time. We will not allow more than 40 participants at a time. Lodging boarding arrangements will be done by you.
- In view of Corona, and low fee than normal, we have no provision for kitbag.
 Only e-certificate and trophy will be given. No arrangement of Breakfast or lunch during presentations for Option-3.
