VIRTUAL PARTICIPATION:

- a) Rs.11,000/- only plus GST per QC Team (Up to 5 members participation)
- b) Rs.6,600/- only plus GST per Allied Concept Team (Up to 3 members participation)
- c) For each additional member participation in a QC Team beyond 5 members will attract an investment of further Rs.2,200/- only plus GST per person.
