## Terms & condition - Extract from constitution

"Member" means a Member of the Forum in accordance with these Rules and includes Patrons and Institutional Members. "Financial Year" means the twelve months commencing on the first day of April and ending with the thirty-first day of March of the following year.

"Registered Office" means the Registered Office of the Forum situated at 306, 3rd Floor, Navketan Chambers, 62, Sarojini Devi Road, Secunderabad - 500 003, Telangana, INDIA or such other place to which the office may be shifted as may be decided by the Executive Board.

- 2.2 ADMISSION OF MEMBERS
- 2.2.1 An application in the prescribed form shall be made for admission to the membership of the Forum. The Executive Board or its committee at its discretion may grant or deny membership after considering the application.
- 2.2.2 Every application for admission shall be accompanied by the annual subscription fee and admission fee, as applicable and as determined by the Executive Board from time to time.
- 2.2.3 It shall be competent for the Executive Board to reject any application for admission without assigning any reasons therefore
- 2.4 CESSATION OF MEMBERSHIP
- 2.4.1 A member shall ipso facto cease to be a member of the Forum -
- 2.4.1.1 In the case of an individual, if he is found to be of unsound mind or applies to be adjudicated an insolvent or is adjudged an insolvent or is convicted by a court of any offence involving moral turpitude.
- 2.4.1.2 In case the member is a firm, if it is dissolved or adjudged insolvent or if any of the partners of the firm are convicted of an offence involving moral turpitude.
- 2.4.1.3 In case the member is a company if it goes into liquidation.
- 2.4.1.4 If the member is expelled from the Forum under clause 2.4.2
- 2.4.1.5 If the member fails to pay debts due to the Forum after the member's name had been posted for non-payment under clause 2.4.3.
- 2.4.2 If any member shall refuse or neglect to comply with any provisions of the Memorandum or of these Rules or of any Regulations formed hereinafter or shall be guilty of misconduct such that the Executive Board considers likely to endanger the harmony or affect the character and stability or interests of the Forum, such member may be expelled by the Executive Board, after giving the member an opportunity to show cause why the action of expulsion should not be taken against him.
- 2.4.3 If any member fails to pay the subscription or any other money due and payable by him to the Forum for a period of ninety days after the same has been duly demanded of him in writing, the member shall cease to be a member of the Forum.
- 2.5 RE-ADMISSION
- 2.5.1 A member who has ceased to be a member of the Forum can be re-admitted at the discretion of the Executive Board or its committee.
