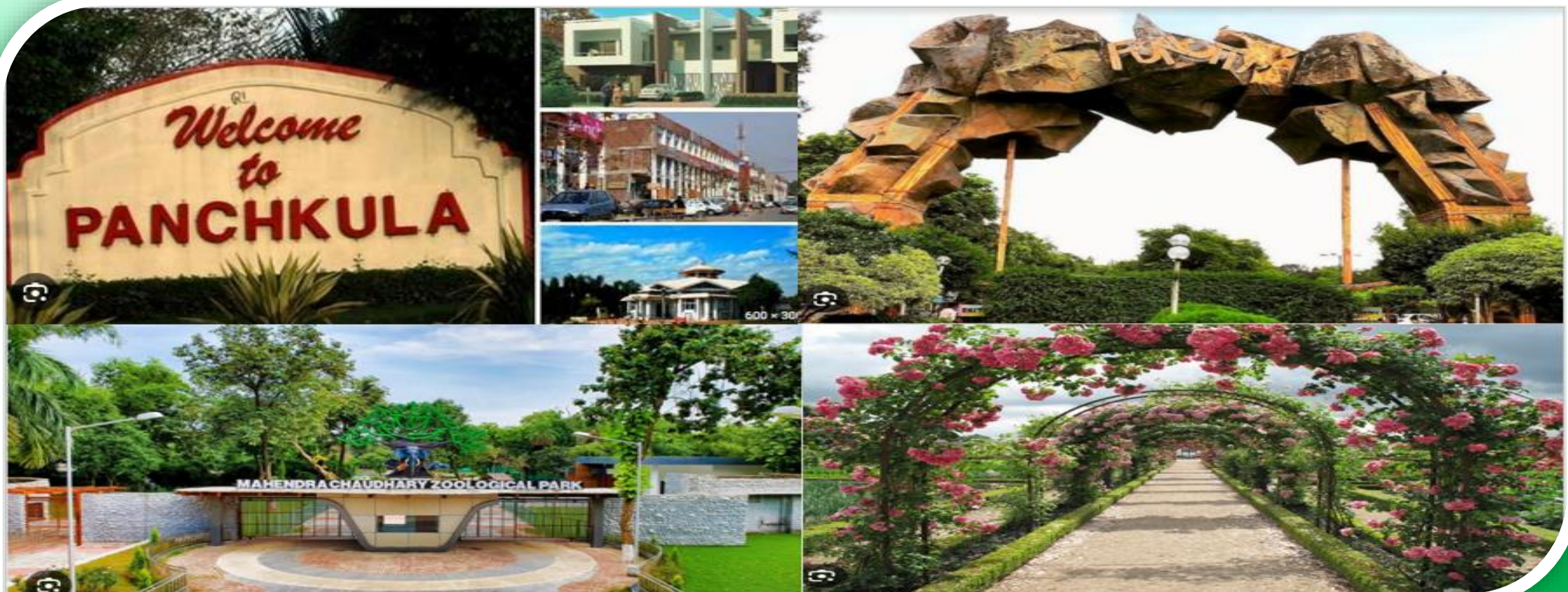

- For other Allied concepts- Pre-evaluation+ Case study Presentation.
- Maximum presentation is for 15 minutes in addition to 3 minutes for questions by Judges.
- The Participant name, Organization name, Team Name etc. details should be clearly mentioned in first Slide of Case study.
