

Send your case study in ppt mode with description/ story, in WE share or Google drive & send link. Language should be Hindi or English. Last date for receiving case studies by 15th Sep 2024. Judges will evaluate presentations and their decision will be final and binding. Case study & presentation evaluation criterion are as per HO guidelines. (Refer evaluation Criterion). Winning certificates will be given at the CCQC venue itself. Awards will be given to teams based on evaluation along with certificate and trophies. Gold (70% & above), Silver (60% & Above) & Bronze award (below 60%).

On the spot Quiz will be conducted at Venue.
