- If an organization is performing well but does not have a team selected under the above criteria, the chapter may nominate one best team per unit for participation.
- Teams eligible for ICQCC 2025 but unable to attend due to work exigencies may still participate in the offshore convention. Evaluation criteria of ICQCC 25 will be followed for such teams and award will be given accordingly by QCFI.
